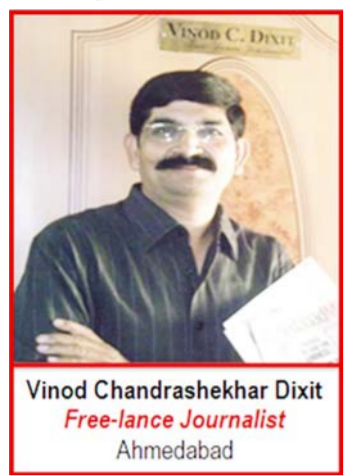


# My Sorrow over missing Sparrow Omar Abdullah lashes out at PDP and BJP as flood threat looms large in J&K

Let us remember that the World Sparrow Day which we observe every year is not just a one-day event to celebrate the ubiquitous, but fast-disappearing sparrow, but we need to make an attempt to raise public awareness about the decline of the house sparrow and throw light on the problems faced by the species in its daily fight for survival, but inspire people to take concrete steps. There is an urgent need to understand the status of our commonest bird, the ubiquitous house sparrow.

## A Day After Meeting Amit Shah, Four Bengal Families Join Trinamool Congress

Kolkata: A day after BJP President Amit Shah reached out to a number of rural families in West Bengal's Purulia district as part of his party's 'Jan Sampark Abhiyan', the members of four such families joined the state's ruling Trinamool Congress on Friday.

Trinamool leaders, who handed them the party flag in front of the media, claimed the innocent villagers were threatened by Shah to join BJP.

Purulia resident Phachu Rajbhor, whom Shah met on Thursday, said they are not into politics but feel an affinity towards Trinamool and its supreme Mamata Banerjee. He revealed they have come to Kolkata to seek Trinamool's help after Shah went to their house.

"We have come here on our own because we were scared after his visit. No one has forced us to come here. We know Trinamool Congress and Mamata. We want her 'refuge'," Rajbhor said sitting beside Trinamool leader Madan Mitra at a party office. Asked whether they were asked by the BJP President to join the saffron party, the youth initially revealed they had no conversation with Shah, but later claimed they were threatened.

Mitra, who accused Shah of trying to mislead the tribal and backward classes in Purulia and thus attempting to foment trouble in the state, handed over the party flags and membership to the families.

"These are poor people who are least bothered about Amit Shah and BJP. People of Bengal have no time for such parties. They felt scared when Shah entered their humble houses and mistook him for a dacoit. So they have come here to take our party's refuge," claimed Mitra, the former Trinamool Congress MLA, who was arrested by the CBI in relation to the Saradha chit fund scam.

**SRINAGAR:** Former Jammu and Kashmir chief minister Omar Abdullah on Saturday lashed out at Mehbooba Mufti-led government amid threats of a flood-like situation in the state. With river Jhelum flowing over the danger mark, Omar questioned the preparedness of the government in the state. "What was the PDP-BJP government doing after the devastating floods of 2014? What happened to the dredging of the Jhelum? Why was the carrying capacity of the flood channel not increased? Where did the money go," Omar tweeted on Saturday.

Heavy rains in Kashmir forced the authorities to sound a flood alert in central Kashmir on Saturday and asked the people to be alert and prepared for evacuation, even as water levels started receding in the southern parts of the valley. The authorities had on Friday issued a flood alert in south Kashmir. Owing to the flood warning in the state, Governor NN



Vohra chaired an emergency meeting at Raj Bhawan on Saturday. The schools across the valley have been shut for a day in view of the inclement weather.

"The gauge at Ram Munshi Bagh crossed the flood declaration of 18 feet and was flowing at 20.87 feet at 10 am," an official of the Irrigation and Flood Control Department said. He said the people living in areas along the embankments of Jhelum river and other streams and in low-lying areas of central Kashmir were advised to remain vigilant. "The staff deputed on flood duty in central Kashmir is directed to re-

beats," the official added.

In south Kashmir the water level crossed the flood declaration level of 21 feet at Sangam in Anantnag district of south Kashmir. Following which the flood alert was sounded. While the water level at Sangam at 10 am this morning was 23.06 feet still above the critical mark the water has started receding there. At 9 am the water level there was 23.16 feet.
